It is a not for profit company limited by guarantee, of which 80% is owned by schools and colleges and 20% by Sheffield City Council. Learn Sheffield does not distinguish between different types of setting; it is there to support any publicly funded school or college working with Sheffield's children and young people.

It is currently consulting on its priorities and you can have a say. These priorities have been developed with a wide range of different stakeholders in Sheffield's education system. Private Hire Vehicle and Operator Policy consultation – Sheffield City Council Closes Friday 20 May 2016, 5pm

Sheffield City Council is responsible for the regulation of private hire vehicles, operators, and drivers within the city boundary. The principal purpose of private hire operator and private hire vehicle licensing is to protect the public and to promote public safety, and with this in mind the Council will promote:

- The protection of the public, safeguarding children and the vulnerable, prevention of crime and disorder, prevention of public nuisance
- The provision of professional, courteous and knowledgeable licence holders
- The vision and objectives of Sheffield City Council

The Licensing Service is currently reviewing its policies in relation to private hire operators and private hire vehicles in Sheffield. The uneven impact of welfare reform report available to download

The uneven impact of welfare reform report by Christina Beatty and Steve Fothergill from Sheffield Hallam University's Centre for Regional Economic and Social Research is now available to download at www.shu.ac.uk/research/cresr/reports. This new report brings the story forward by including the welfare reforms announced since the May 2015 general election. It also updates all the figures for the pre-2015 reforms to take account of the actual outturn. This enables an assessment not only of the cumulative impact by the end of the present decade but also of how much has happened already and how much is still in the pipeline.
